Virtual Seminars for San Mateo County Candidates for the November 8, 2022 Statewide General Election *Interested Candidates are Encouraged to RSVP*

(Redwood City, CA) The San Mateo County Registration & Elections Division is offering seminars on candidate filing for potential candidates interested in running for office in the upcoming November 8, 2022 Statewide General Election. Candidates will also learn about purchasing and using voter and election data for campaigning and voter education.

The candidate seminars for the November 8, 2022 Statewide General Election will be conducted online via Microsoft Teams. Once you have signed up online, a meeting invitation with a link to the online seminar will be emailed to you.

“I highly recommend that anyone interested in serving their community attend the seminars. Even if you have run for office before, these briefings will ensure your understanding of current laws, forms, reporting rules, and campaign management tips,” said Mark Church, Chief Elections Officer & Assessor-County Clerk-Recorder.

The **Candidate Seminar** will cover such areas as:

- Important filing deadlines
- Candidate filing documents
- Candidate statement
- Campaign finance reports
- Voter data reports

Voting Period Begins October 10 and Ends on November 8

Early voting period starts in October, with three Vote Centers opening in San Mateo, Redwood City and South San Francisco.
