**Facility Use Group Descriptions (all organizations must provide a facility use application, insurance, and a 2 hour minimum fee if custodial is required)**

<p><b>Priority 1 District and District-sponsored groups</b></p>	<p><b>Examples: (1) games, practices, meetings, performances, and other events sponsored by the school district and supervised by a district employee, (2) auxiliary organizations, e.g., PTA, (3) WSF*, (4) recognized school clubs &amp; student body organizations *WSF auction donations are Priority 1 for Facilities Use with insurance.</b></p>
<p><b>Priority 2 Department and agency meetings of local government entities</b></p>	<p><b>Examples: (1) Town of Woodside (2) Woodside Fire Department, (3) Woodside Recreation Commission</b></p>
<p><b>Priority 3 District-based community organizations and groups formed for educational, political, economic, artistic and moral interests of the community</b></p>	<p><b>Examples: (1) use of facilities for organizations including summer camps and outside student activities (3) civic organizations and service clubs, (4) educational groups *Teacher lead summer camps are considered a community benefit and are subject to 10% of charged revenue fee.</b></p>
<p><b>Priority 4 Other approved groups or organizations (ie, AYSO, Little League)</b></p>	<p><b>Examples: (1) AYSO, Little League or other non-profit youth sports leagues, (2) registered non-profit organizations where receipts are expended for charitable purposes (3) non-profit adult sports leagues (4) for profit student sports leagues (5) adult sports leagues</b></p>
