Temporary Total Disability

TTD is one of those things everyone hears about, but almost nobody actually understands until they're in the middle of it. So let's break it down in plain English.

What is TTD?

TTD stands for Temporary Total Disability. It's a wage replacement benefit paid when a work-related injury or illness prevents you from working at all. It's not extra pay and not a settlement, it's meant to help replace part of your paycheck while you recover.



When do TTD payments start?

California has a 3-day waiting period before TTD begins. This means you generally must miss more than three days of work due to your injury before wage replacement starts.

• Do the days have to be consecutive?

Not necessarily. If your time off adds up to more than three days because of the same injury, the waiting period can be met.

• If you're off work more than 14 days, those first three days are usually paid retroactively.

WORKERS COMPENSATION

Who sends the check?

For SMCSIG members, Intercare is the TPA (Third Party Administrator), and your Intercare claims examiner is the one who issues TTD payments, not your district and not SMCSIG directly.

Who do I call if my check is late or missing?

Your first call should be your Intercare claims examiner. If you don't know who that is, your HR department or SMCSIG can help you get the right contact.

What if the doctor says I can work light duty?

If your doctor releases you to modified or light duty, and your employer offers work within those restrictions, you're generally expected to return to work. In that situation, TTD usually stops, because you're no longer totally unable to work. Returning as directed by your doctor allows you to return to your regular pay that you received before the injury occurred.



The bottom line

TTD is there to support you when you truly can't work—but it depends on your doctor's work status and whether modified duty is available. When in doubt, your Intercare claims examiner or HR can help keep things clear and on track.




